WILLIAM, NO. 1, SIXTY (60) DAYS PRIOR TO THE ANNUAL GRAND CONCLAVE FOR REVIEW AND APPROVAL OF THE JURISPRUDENCE COMMITTEE.

**MANDATE NO. 15**

EMINENT COMMANDERS, GENERALISSIMOS, CAPTAIN GENERALS, SENIOR WARDENS AND JUNIOR WARDENS ARE REQUESTED TO ATTEND EASTERN DIVISIONAL COUNCIL MEETINGS; APPOINTED COMMANDERY OFFICERS, PAST EMINENT COMMANDERS AND SIR KNIGHTS ARE ENCOURAGED TO BE IN ATTENDANCE. **EASTERN DIVISIONAL COUNCIL MEETINGS** WILL CONVENE AT 12:00 NOON ON THE FIRST SATURDAY OF THE MONTH AT ROSE OF SHARON LODGE, 2<sup>ND</sup> FLOOR, 319 N. 9<sup>TH</sup> STREET, DARBY, PENNSYLVANIA, 19023.

**MANDATE NO.16**

STATE DIVISIONAL COMMANDER AND DIVISIONAL COMMANDERS, DIVISIONAL COMMANDERS AND THE DIVISIONAL LECTURERS WILL RATE THE COMMANDERIES ASSIGNED TO THEM TO SEE HOW EACH COMMANDERY IS PROGRESSING. THE DIVISIONAL COMMANDERS WILL REPORT TO THE STATE DIVISIONAL COMMANDER, WHETHER THE COMMANDERIES HAD SUBMITTED THEIR QUARTERLY FINANCIAL RETURNS IN A TIMELY MANNER AND HAD RETURNED THEIR ANNUAL ELECTION FORMS AND DATA SHEETS AS ORDERED. **MANDATE NO. 17**

QUARTERLY STAFF MEETINGS - ALL ELECTED LINE OFFICERS ARE REQUIRED TO ATTEND QUARTERLY STAFF MEETINGS WITH THE MOST EMINENT GRAND COMMANDER AT 4301 NORTH BROAD STREET, PHILADELPHIA, PA 19140 (DATES, TIMES AND PLACES TO BE ANNOUNCED.) ALSO, ALL ELECTED LINE OFFICERS ARE REQUIRED TO SUBMIT A MONTHLY REPORT OF THEIR ACTIVITIES BY THE FIFTH DAY OF EACH MONTH - NO EXCEPTIONS! THE STATE DIVISIONAL COMMANDER AND STATE GRAND LECTURER ARE TO RECEIVE - SAID MONTHLY REPORTS.

**MANDATE NO. 18**

THE STATE DIVISIONAL COMMANDER CALVIN L. JOHNSON NO. 17, WILL HAVE CHARGE OF ALL DIVISIONAL COMMANDERS, SCHOOLS AND ASSIST THE STATE GRAND LECTURER, SIR LEE ROBINSON NO. 1, WHO WILL BE RESPONSIBLE FOR ALL INSTRUCTIONS PERTAINING TO THE AUTHORIZED RITUAL OF THE UNITED GRAND COMMANDERY. HE WILL SUPERVISE ALL DIVISIONAL LECTURERS AND WILL ASCERTAIN THAT NONE OTHER THAN THE AUTHORIZED

RITUAL OF MASONIC KNIGHTS TEMPLAR, JURISDICTION OF PENNSYLVANIA IS UTILIZED. HE WILL ALSO PUT TOGETHER A COMPETENT TEAM, THROUGH TRYOUTS OF MASONIC KNIGHT TEMPLARS TO PERFORM THE ANNUAL MEMORIAL SERVICE, CHRISTMAS TOAST AND PASSION NIGHT PLAY. **MANDATE NO. 19** RETAIN, RECLAIM, RECRUIT AND REVITALIZE

**MANDATE NO. 21** RECOGNITION, OF FESTIVE DAYS

IT IS HEREBY ORDERED THAT NO COMMANDERY, SWORD CLUB OR UNIT OBEDIENT TO THE UNITED GRAND COMMANDERY, MASONIC KNIGHTS TEMPLAR PHA, JURISDICTION OF PENNSYLVANIA SPONSOR, CONVENE OR PARTICIPATE IN ANY EVENT ON A DATE WHEN A GRAND BODY OF THE PRINCE HALL FAMILY OBSERVES THEIR FESTIVE DAYS OR ANNUAL SESSION AND MID YEAR GL SESSION. THIS ORDER WILL BE STRICTLY ENFORCED.

**MANDATE NO. 22** DISPENSATIONS

ALL REQUESTS FOR DISPENSATION ARE TO BE SUBMITTED DIRECTLY TO YOUR RESPECTIVE DIVISIONAL COMMANDER SIXTY (60) DAYS PRIOR TO THE DATE OF THE ACTIVITY (DEGREE WORK, CHURCH SERVICE, OUT OF STATE VISITATION, CHANGE OF MEETING, BANQUET, SOCIAL ACTIVITY [SWORD CLUB], ETC.). ALL DATES FOR SOCIAL FUNCTIONS INCLUDING TICKETS, PROGRAMS, FLYERS AND SOUVENIR JOURNALS ARE TO BE APPROVED PRIOR TO AND AFTER PRINTING. WHEN INVITING THE MOST EMINENT GRAND COMMANDER AND/OR THE MOST

WORSHIPFUL GRAND MASTER, PROPER PROTOCOL MUST BE ADHERED TO. ALL QUESTIONS ARE TO BE DIRECTED TO YOUR RESPECTIVE DIVISIONAL COMMANDER.

**MANDATE 23**

THE MOST ROYAL GRAND CHIEF ENGINEER AND THE DEPUTY GRAND CHIEF ENGINEER ARE REQUIRED TO WEAR FULL DRESS UNIFORM WHEN REPRESENTING THE UNITED GRAND COMMANDERY OR THE MOST ROYAL GRAND COURT OF CYRENE:

- (5.) MOST ROYAL GRAND COURT OF CYRENE LUNCHEONS & BANQUETS.
- (6.) CELEBRATION OF TEMPLARISM'S "CHRISTMAS TOAST"
- (7.) AT OTHER EVENTS, FUNCTIONS AND OCCASIONS, WHERE THE FULL-DRESS UNIFORM IS CONSIDERED UNNECESSARY BY THE MOST EMINENT GRAND COMMANDER.

**MANDATE 23A**

THE MOST ROYAL GRAND CHIEF ENGINEER AND DEPUTIES ARE REQUIRED TO ATTEND A MINIMUM OF SIX (6) OF THEIR SUBORDINATE COMMANDERY'S CONCLAVES EACH YEAR.

**MANDATE 23B**

THE MOST ROYAL GRAND CHIEF ENGINEER AND DEPUTIES ARE REQUIRED TO SUBMIT A WRITTEN REPORT MONTHLY. SAID MONTHLY REPORTS WILL BE PRESENTED DIRECTLY TO THE MOST EMINENT GRAND COMMANDER – NO EXCEPTIONS

**MANDATE 23C** ENGINEERS' COUNCIL

THE PRESIDENT OF THE ENGINEERS' COUNCIL SHALL SCHEDULE THE ENTIRE ENGINEERS' COUNCIL MEETINGS FOR THE YEAR FOLLOWING THE CONSULTATION WITH THE MOST ROYAL GRAND CHIEF ENGINEER, WHO WILL THEN INFORM THE MOST EMINENT GRAND COMMANDER. THE ENGINEERS DO NOT HAVE TO PAY DUES TO THE ENGINEERS' COUNCIL.

**MANDATE NO. 23D** ENGINEERS

ALL ENGINEERS, WHO ARE IN GOOD FINANCIAL STANDING WITH THEIR SUBORDINATE COMMANDERIES, ARE PERMITTED TO VOLUNTARILY PAY DUES IN THEIR RESPECTIVE SUBORDINATE ROYAL COURTS OF CYRENE, UNLESS THEY ARE EXEMPTED FROM DUES, SPECIFICALLY THOSE ROYAL COURTS UNDER THE AUSPICES OF THE MOST ROYAL GRAND COURT OF CYRENE (ACCEPTED AND ADOPTED BODY OF THE UNITED GRAND COMMANDERY, MASONIC KNIGHTS TEMPLAR - P.H.A., JURISDICTION OF PENNSYLVANIA). THE SAID ENGINEER SHALL BE ENTITLED TO VOTE AND HAVE VOICE IN THE ROYAL COURT COLLECTING HIS DUES. IF THE SAID ENGINEER SHALL BECOME UNFINANCIAL IN HIS COURT, HE SHALL FORFEIT THE PREVIOUSLY SPECIFIED RIGHT TO VOTE AND VOICE HIS OPINIONS.

#### **MANDATE NO. 24**

COMMANDERIES SERVING THIS JURISDICTION OF PENNSYLVANIA ARE DIRECTED TO SUBMIT AN UP-TO-DATE MEMBERSHIP ROSTER AND RETURN THE RECENTLY DISTRIBUTED MEMBERSHIP DIRECTORY FORMS TO THE **EMINENT GRAND RECORDER**. THIS INFORMATION SHALL BE USED TO CREATE, UPDATE AND HELP ASSIST A SIR KNIGHT DATA BASE AND MEMBERSHIP DIRECTORY.

#### **MANDATE NO. 25**

EMINENT COMMANDERS ARE RESPONSIBLE AND SHALL BE HELD ACCOUNTABLE FOR ORGANIZING THEIR COMMANDERY'S **FUNERAL TEAM**. THE DESIGNATED FUNERAL TEAM WILL DEMONSTRATE ITS PROFICIENCY TO THE STATE GRAND LECTURER. THE GRAND LECTURER HAS AUTHORITY TO ACCEPT, REJECT AND MODIFY THE FUNERAL TEAM'S PRESENTATION. THE FUNERAL TEAM IS PROHIBITED FROM USING ANY WRITTEN MATERIALS DURING THE PRESENTATION!

#### **MANDATE NO. 26**

SIR KNIGHTS SERVING THIS JURSDICTION ARE **PROHIBITED** FROM IMBIBING OR EXHIBITING ALCHOLIC BEVERAGES WHILE ATTIIRED AS A MASONIC KNIGHT TEMPLAR. THIS IS INCLUSIVE OF OUR FULL DRESS OR FATIGUE UNIFORMS, JEWELS, BADGES, EMBLEMS, BANNERS, PINS, BUTTONS OR NAME PLATES THAT DISPLAY THE TEMPLAR SYMBOL OR LOGO. SIR KNIGHTS, TAKE HEED AND GOVERN YOURSELVES ACCORDINGLY!

#### **MANDATE NO. 27**

ALL RECOMMENDATIONS AND RESOLUTIONS SHALL BE SUBMITTED AND IN THE HANDS OF THE JURISPRUDENCE COMMITTEE AT LEAST THIRTY (**30**) DAYS PRIOR TO THE CONVENING OF AN ANNOUNCED AND SCHEDULED GRAND CONCLAVE OF THIS UNITED GRAND COMMANDERY OF PENNSYLVANIA.

#### **MANDATE NO. 28**


